JOB MARKET PAPER	"The effect of management training on health care provider preferences, clinical decision- making, and business performance in the Kenyan private health care sector" (with Paul Gertler and Ada Kwan).
	This paper studies how managerial training affects clinical decision-making and busi- ness outcomes of private-for-profit clinics in Kenya. We report experimental results of a large-scale management consulting intervention that featured social franchising, bu- siness improvement, and quality accreditation. Treatment clinics showed improvements in management practices and structural quality that translated into more clients, higher efficiency, and higher profitability. We find that the program made providers less al- truistic. The program, however, significantly reduced correct clinical case management of patient care by 7.8% and increased prices by 27%. We show that the fall in qua- lity did not register with clients and did not affect demand, consistent with demand being quality inelastic. We show that the effects on business performance are driven by changes in management, while changes in quality and prices are driven by changes in altruism. Our study contributes to understanding the trade-offs between quantity and quality in primary care in resource-constrained settings, and that interventions aimed at improving management practices must be coupled with accountability mechanisms and interventions to avoid crowding-out of intrinsic motivation.

	This paper investigates the medium-term effects of the Skills for Effective Entrepre- neurship Development (SEED) program, an in-residence 3-week mini-MBA program for high school students, modeled after western business school curricula and adapted to the Ugandan context. We demonstrate that the training was effective in improving hard and soft skills after 3.5 years, but only soft skills were linked to improvements in self- efficacy, persuasion, and negotiation. The skill upgrade was rewarded in substantially higher earnings, most of which was generated through an increase in self-employment.

	This paper studies the variation in unit cost across different service delivery platforms for four HIV interventions, as part of the Global Health Cost Consortium (GHCC) initiative. Using Targeted learning methods and observational data, we estimated the difference in unit cost between a) clinics and hospitals; b) public and private facilities; c) urban and rural facilities. Our paper synthesizes multiple studies that are heteroge-

neous in scope and measurement, and aims to improve effective budgeting by informing

program planners, policymakers, and funders.
